Tickets are valid at participating PSCWA car washes throughout the Puget Sound area. A list of member wash sites can be found on the back of each ticket and <http://www.bakeco.com/broc-car-wash-fundraiser.pdf>. Suggested selling price is \$8 per ticket. Profit potential is 75%.

You can increase sales by offering a customer volume ticket pricing—example: one ticket for \$8, three tickets for \$20, ten tickets for \$70. The customer receives a discount and you sell more tickets. **Wash center pricing may vary by site**, but each ticket is valid for one exterior wash. Customers may upgrade service on site by paying the difference. You may continue to re-order tickets as needed. Allow up to 5 working days to process the application and receive your imprinted tickets. Tickets are not valid for large commercial vehicles, fleets or oversized vehicles. **Note: Tickets are valid for SIX months and will NOT be reissued if unsold or lost.** Tickets are mailed via USPS Priority Mail. **Choose from these options:**

- I wish to **defer payment using VISA/MC as a personal payment guarantee**. A check or money order for the total amount due will be received at BAKE & Co. **within 14 days** or the VISA voucher will be processed. There will be an added \$50 fee for a declined card. Amount due will be delinquent after 30 days from issue. Customer will bear all costs involved in collections.
- Please process the credit card below as full payment for tickets ordered. (Secure fax or call 206.938.4866 with card info).
- Please send one **Charity Car Wash Banner**. Vinyl banner measures 2 x 4 feet with grommets for hanging and reads "Support Our Fundraiser, Professional Car Wash Tickets Sold Here." I understand this banner must be returned in like new condition to BAKE & Co. at the end of our sale or we agree to pay the \$75 replacement fee. **Banner on 200 or more tickets.**
