TIMELINES : Expect a 7 to 10-day turnaround time from the day you submit a request for artwork or provide artwork until you receive a virtual digital example sent as an electronic file to your e-mail. Upon approval of artwork, allow a FULL 30 days for strap only orders, and up to 60 days for strap and footbed designs. Shipping is included in the price via UPS ground from Florida to a business address. Shipping to Hawaii or a residential address will incur extra charges. BAKE & Co. will provide an electronic presale order-collection form with a .jpg photo of your approved design on the form. Customer will make their own copies. BAKE & Co. will provide an announcement letter in MS Word for you to finalize and print as well as tally forms to help you summarize your sale results.

Unless we approve a purchase order and references are approved by BAKE & Co., payment is due in full with order.

A sample shoe (not pair) with your design is available for a prepaid non-refundable fee of \$65.00.

A fee of \$40 will be charged for returned checks.

A sample shoe will be sent on request to show to committee members and sales participants, it will be a design and size of vendor's choice, one shoe, not a pair.

If hosting a presale order-taker program, instruct sellers to collect money at the time they accept the order, returning both to the chairperson by the due date.

DESIGN DEPOSIT AND CANCELATION: We charge a \$30 payment guarantee to produce a design for your approval.

If we create a digital design for you, and you do not proceed with your sale, the \$30 design fee will be forfeited. If you cancel your sale and BAKE & Co. has already prepared custom sales materials, you agree to pay a \$40 cancellation fee for our services. You will also forfeit any costs for custom brochure imprinting and mailing.

If shoes are "in production" and you cancel the order, you will be billed the entire amount due for the order whether or not you take delivery!

There are no product returns or exchanges with this program. It is recommended you purchase extra design tags.

An additional or replacement shoe can be made available with instructions how to affix the tags.

TAX: Printed materials do not include sales tax. You are responsible to collect and pay any and all applicable taxes.

DELIVERY : Good are shipped directly from the factory in Florida in bulk, 25 pair per case. BAKE & Co. accept no liability for delays or errors due to conditions beyond our control, including but not limited to manufacturer's supply shortages, shipping delays, loss or damage. Manufacturer's warranties apply.

BAKE & Co. makes every effort to ensure timely and accurate orders and delivery. We will provide tracking numbers on shipments.

Customer agrees to personally take delivery, count cases against the shipper's packing slip, and verify there are no missing cases or product damage.

Customer agrees to count case contents by size and design ordered PRIOR to making any distribution to sellers or waives their right to free correction due to omissions.

CONFIDENTIALITY: All customer information is kept strictly confidential. We do not share or sell mailing lists. Faxed information is received at a secure location.

Customer receipts bearing credit card information reveals only the last four digits of the number if transferred electronically for your security.

OUR GUARANTEE : BAKE & Co. offers an unconditional money-refunded guarantee on quality. We offer a full replacement or refund guarantee on any damaged item.

Only the \$30 design guarantee is due at this time. This Sales Agreement will be our work sheet to provide you with the best design based on your detailed preferences. We will send an e-mail with a digital sample for your final approval. Upon your design approval, we will provide you with a "promotional" packet of documents created in MS Word and Excel that you can edit and finalize to help coordinate your fundraiser and tally your sales results. At the completion of your sale, you will be asked to fax an Order Submittal Form. We will generate an invoice based on the cost of the shoe design you have chosen. Upon receipt of payment, we will submit your order to the supplier. **Allow a FULL 30 days to ship!** Order carefully; there are no returns or exchanges with this program and any future orders will again need to meet the 100 pair minimum.

Because fundraising often incurs late orders or the need for exchanges, we will make additional tags available to you in sets of 25 for \$15 per set. We strongly encourage you to purchase at least one set of extra tags. You may then order more cases of 25 pair in your choice of sizes. The rubber tags can be easily affixed to the rubber sandal with a glue we will furnish at no charge in a 2oz. bottle, enough for 100 pair. Order as many "extra" sets of tags as you think you might need for the future.

Addendum to Terms of Sale:

We understand each order will take up to 30 days for delivery from the date the approved design and order is sent to the supplier.

We understand our minimum order will be 100 pair and we can choose one shoe color per case in assorted sizes.
