

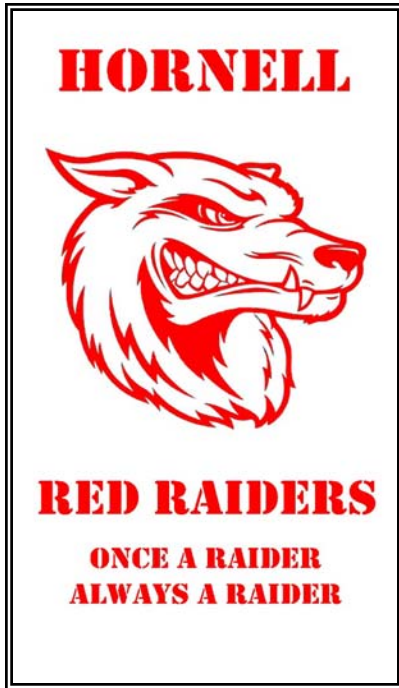

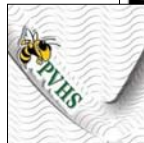

 Shipping is included in the price via UPS Ground. Customer pays freight on orders to Hawaii. We do not ship to Canada or Alaska with this program.  
 On request, BAKE & Co. will provide an electronic presale order-collection form with a .jpg photo of your approved design on the form. Customer will make their own copies. A fee of \$50 will be charged for returned checks.

If hosting a presale order-taker program, instruct sellers to collect money at the time they accept the order, returning both to the chairperson by the due date.

**TAX:** Printed materials do not include sales tax. You are responsible to collect and pay any and all applicable taxes.

**DELIVERY:** Goods are shipped directly from the factory exact to the piece ordered.
