THIS FORM IS YOUR ORDER FORM AND YOUR INVOICE. Keep it for your records and/or to make payment. Note that whatever color awareness ribbon you choose, it will be on a black tag background. The best color combinations for awareness ribbon flip flops are white shoe or black shoe with your choice of ribbon color. Allow up to two weeks for us to process your order plus shipping time UPS ground. To ensure accuracy of order, keep it simple. We recommend no more than two shoe colors.

ORDERING: Minimum order is TWO cases on your initial order. Choose your shoe color (size 11/12 not available in pink or orange). Choose your ribbon color. Each case must contain 25 pair; shoe color and ribbon color may be mixed, although offering only one or two shoe colors is strongly suggested. Not all cases must be the same. Select your preferred sizes. These are featured as women's shoe sizes (see men's comparable size as noted). Sizes tend to run true or slightly smaller. If unsure of your size, and you are at the upper 1/2 size, best to go up one size. Example: If you wear a 7 it should fit fine. If you wear an 9-1/2, best to round up to a 10/11. We do not ship to Alaska. Order shipped to Hawaii will incur additional shipping charges.

THE PROCESS: Once we receive this completed form with a tax identification number and full payment (unless credit terms have been extended), we will release your order for shipping to the delivery address you have indicated on this form. We cannot ship to a P.O. Box. We expect someone to be available to accept the delivery in person. We will not be responsible for product left on door steps regardless of any other arrangements you have with local UPS or other delivery services. You may call to request a tracking number when your order is shipped from Florida UPS Ground. We prefer to ship to a commercial/business address rather than residential.

PAYMENT: We accept checks drawn on your organization's account, money orders, VISA and MasterCard. We do not accept any other credit cards. OUR FEE FOR NSF CHECKS IS \$50! Any credit card information written onto this form and faxed to us is secure on this end and viewed only by the owner. You may prefer to call us if you do not want your credit information on the faxed paperwork. IF credit terms are extended, payment must still be guaranteed with a credit card which we will hold until payment is received. If payment is not received within 30 days, a check is returned, or the card is declined due to non payment, collection of amount owed is immediately turned over to collections. For first-time customers, we will release your order for shipping upon receipt of payment. We reserve the option to offer other payment terms on a case-by-case basis. Please do not mail cash.

If your organization wishes to issue a purchase order number, please note we accept these on a limited basis depending on the amount. At least two credit references with contact information are required. A partial payment may be requested. In all cases, a paper copy of the actual purchase order must be faxed to us (206) 938-1746 before we will release an order for shipping. Our payment term on purchase orders is net 15 days from delivery.

CANCELLATION: If you cancel your order after it has been sent to the supplier for manufacturing, you are still be responsible to pay the full amount due in full. There are no returns or exchanges with this program so order carefully.

DELIVERY: Goods are shipped directly from the manufacturer. BAKE & Co. accepts no liability for delays or errors due to conditions beyond our control, including but not limited to manufacturer's shortages, weather, shipping delays or errors, loss or damage. Manufacturer's warranties apply. BAKE & Co. makes every effort to ensure timely and accurate delivery. We will provide tracking numbers when your order has been shipped.

LOSS OR DAMAGE: PLEASE count your cases upon delivery. If a box is missing you must record the tracking numbers of the boxes that you did receive so we can track the missing case. Failure to take this step relieves BAKE & Co. from providing a replacement case. Please inspect all boxes for damage and call us at 1-800-535-2253 if there are any missing items or damage. Be sure to also count shoes in each case BEFORE you do your distribution to retail sale sellers.

TIME LINES: Be prepared to allow up to two weeks for your order to ship plus UPS ground transportation time which can add another five business days. On occasion the FL supplier is out of stock; shipments from Brazil--clearing customs--can take one month or more. You may change your order, accept partial shipment, or wait for the whole order to ship at one time.

TAX: You are responsible to collect and pay any and all applicable taxes should they apply in your state for non-profit fundraising.

OUR GUARANTEE: BAKE & Co. offers an unconditional money-refunded guarantee on quality. We offer a full replacement or refund guarantee on any damaged items (digital photo is extremely helpful).
